

**SUTTER LAFCO
NOTICE OF PUBLIC HEARING**

Notice is hereby given by the Local Agency Formation Commission (LAFCo) that public hearings will be held on **Thursday, May 11, 2023 at 2:00 p.m. in the Yuba City Council Chambers**, 1201 Civic Center Boulevard, Yuba City, California, regarding the following:

1. The Commission will consider the **Final 2023-2024 LAFCo budget** to make a final determination thereon by the Commission. Any person may be heard regarding the increase, decrease or omission of any item from the budget or for the inclusion of additional items.
2. The Levee District #1 is requesting LAFCo modify the District's boundaries to annex approximately 5,833 acres into the District and to modify the District's sphere of influence (SOI) to include the annexed lands which consists of the southern benefit area currently protected by the Levee District #1 Levees and the lands fifteen (15) feet from the waterside toe of the Feather River west levee. In general lands south of Marcus Road and northwest of the Sutter Bypass Levee including the Feather River Levee.

The Commission will consider oral and written testimony by any interested person or affected agency as well as the report of the Executive Officer. At the hearing, the Commission may approve or disapprove a proposal with or without amendment, wholly, partially, or conditionally, may include or exclude territory in an annexation or may continue its consideration with or without amendment, as a whole, in part, or upon such conditions as the Commission may determine (For reconsideration requests the consideration may be continued from time to time but not to exceed 35 days from the date specified in this notice). The extension or continuation of any previously authorized charge, fee, assessment, and (or) tax by a local agency or a successor local agency may be applied to the affected territory. The Commission may waive protest and election proceedings if no written protests or objections are received by LAFCo prior to the closing of the public hearing by persons either owning land within the subject territory or, in the case, the territory is inhabited, or by anyone registered to vote who is currently residing within the annexation territory. This notice complies with Section 15182 of the CEQA Guidelines.

Persons may attend and be heard at the time and place of the hearing. If you challenge the action of the Commission on any of the above stated items in court, it may be limited to only those issues raised at the public hearing described in this notice, or in written correspondence delivered to the Sutter Local Agency Formation Commission at, or prior to, the public hearing.

All interested parties have the right to appear and be heard at this time. For further information and review of the files, please contact Sutter LAFCo, P.O.
